- 5. Citizens Comments (on agenda items) -
  - <u>Carl Fleming</u> said his comment was on Executive Session, Item 13B. He said as far as he knew he had not seen any proposals in the paper and no one knows what the proposals may have been. He said he heard one of the proposals was for a race track. He said with a race track, he would like the Council to consider the dark skies aspect in Alpine and the noise factor. He said we have a cattle feed lot close and the animal control center is close by. He said he also did not believe you could put a paved track over a landfill.

He said the Alpine Chamber of Commerce in the 1990's designed the logo by Eric O'Keefe and the two office managers, Linda Chavez and Lucy Escovedo. He said Lucy checked it

out and it meets her approval. He said it says "Home of Sul Ross State University" on the bottom of the logo. He said we did not actually change the logo but added to the bottom, underneath the logo. Councilor Gonzales made a motion, by Resolution 2013-01-07, to approve a new logo for the city including "Home of Sul Ross State University". Motion was seconded by Councilor Bermudez. Councilor Bermudez said he thinks this is a good idea because in all the TML meetings that we attend, as soon as someone says Alpine, they talk about the open meetings act and that it is the home of Sul Ross State University. Mayor Rangra said he gave this to Dr. Maestas also to review, so it did not come as a surprise to him. He said Dr. Maestas liked it. Mayor Rangra said it looks good. Councilor Davidson asked about changing the letterhead. The City Secretary, Molly Taylor, said we also have to change the City Attorney on the letterhead so we will do both at the same time. Motion carried unanimously.

He said there will be people there from China, Czech Republic, and several from Great Britain. He said this will be a lightning fast trip. He said he thought maybe the Mayor and Council would like to go and give that warm Alpine welcome.

Mayor Rangra – said TML is having a meeting on the 1st of February. He said on the 4th is Texas Legislative Day. He said on the 8th Pancho Nevarez, our State Representative will be here, in Alpine for our TML Regional Quarterly meeting. He said going back to the TML meeting in Austin, he called Senator **Uresti's** office and the State Representative's Office to see if they can meet with the Council members and Mayor on the 4th. He said some of us have to come right back. He said Senator Uresti said he could meet with us about 9 or 10 o'clock on the 4th. He said after that we can see our State Representative and express our concerns. Councilor Lujan said he just became aware of this meeting today. The City Manager said there might still be some rooms and registration for the conference was still open. Councilor Lujan asked if he needed to list himself with TML to be notified of those events. The City Manager said these conferences come in with e-mails to every councilmember. Mayor Rangra said they also come in with the monthly magazine "Texas Town and City" that every Councilmember receives every month. The City Manager said everything is also on the website and they

send out an update once every week. Mayor Rangra said he thought Councilor Lujan could still go, if he wanted to, and to check with Abel. The City Manager asked if anyone wanted to sign up and Abel could do that.
