ORDINANCE #2015-11-01

**AN ORDINANCE OF THE CITY COUNCIL OF THE CITY OF ALPINE,
TEXAS, AMENDING CHAPTER 10, CODE OF ORDINANCES – ANIMALS,
ARTICLE I AND ARTICLE II**

WHEREAS, The Animal Advisory Board of the City of Alpine voted in favor of amending Chapter 10, Code of Ordinances – Animals, Article I and Article II; AND

WHEREAS, these amendments included various changes to Chapter 10 of the Animal Ordinance. Article I, beginning with Section 10-1. Definitions, Continued Noise, Frequent or long continued noise, definitions follow this Ordinance as Exhibit “A”; AND

WHEREAS, Article II, Section 10-41(a) Requirements for Outside Dogs and 10-42, Public Nuisances designated, Sub-sections (1) and (3), was amended and amendments follow this Ordinance as Exhibit “B”; AND

WHEREAS, Article II, Section 10-60 Tethering of Animals and Unlawful Restraint of a Dog was amended under Sub-sections (1), (4) and (8) and Section 10-61 – Restriction on Numbers and Types of Animals, Companion Animal Hoarding: Prohibition of Animals at Large and Menacing Animals; which follow this Ordinance as Exhibit “C”; AND

WHEREAS, Section 10-118 Impoundment and destruction was amended under Sub-Sections (b) and (e), which follow this Ordinance as Exhibit “D”; AND

WHEREAS, Section 10-119 Redemption of Impounded Animals was amended under Sub-Sections (a), (b) and (c)(4), which follow this Ordinance as Exhibit “E”; AND

WHEREAS, Section 10-120 (Fees) was amended under all sections, (a)(1-3), (b), (c), (d), (e), (f), (g) and (h) and amendment follow in this Ordinance as Exhibit “F”..

NOW, THEREFORE, BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF ALPINE, TEXAS:

THAT ORDINANCE 2015-11-01 BE PASSED TO AMEND ARTICLE I AND II OF CHAPTER 10, CODE OF ORDINANCES – ANIMALS AS SET FORTH IN EXHIBITS A-F TO THIS ORDINANCE.
