City of Alpine Special City Council Meeting Monday, August 29th, 2016 5:30 P.M. Minutes

- Call to Order, Invocation and Pledge of allegiance to the flags Mayor Ramos called the meeting to order. The meeting was held in the Council Chambers at 803 West Holland in the City of Alpine, Texas. Father Nicholas Roth gave the invocation. Mayor Ramos led the pledge of allegiance to the flags.

5. Public Hearings -

A. Public Hearing to obtain citizens views and comments concerning FY 2016/2017 proposed Property Tax Rate (\$.5385 per \$100 - same as last year's rate) for the City of Alpine, Texas. (E. Zimmer, CM) - City Manager Zimmer said this was our second tax rate public hearing. He said we have not had any phone calls into our office concerning this rate. He said this does give the public the opportunity to speak on this topic. Joseph Goldman from Ward 1 said as he read this public hearing it states that the proposed property tax rate is the same as last year's rate. He said he thinks this is a highly deceptive statement because it implies that the taxes are going to remain the same. He said it is not so and the reason is it isn't so is because property evaluations are going up. He said in order to make it the same tax base as it was last year, the tax rate should come down accordingly. He said he thinks someone on the Council has a degree in mathematics and should be able to calculate how much that rate should go down. Father Nicholas Roth said he lives in Ward 3 however his church is in Ward 4. He said he can understand the point the gentleman was making about the tax rate but unless we can invent some sort of machine that is going to allow us to figure out what everybody's home is worth and then do the math backwards to come up with a different rate, keeping the

rate the same sounds pretty good to him. He said the Council is doing a great job and as long as we can work on paving the roads, take out the trash and making sure the fire hydrants are working, particularly in Ward 4, we are good.

- B. Public Hearing to obtain citizens views and comments concerning FY2016/2017 proposed City of Alpine Budget containing proposed expenditures and revenues from the General Fund, Enterprise Funds, Capital Expenditures and Hotel/Motel Tax funds. (E. Zimmer, CM) Julian Gonzales, Ward 4, said he wanted to ask a question even though he knows he will not get an answer. He said we have been having a lot of cities locally losing the ability to make money and what are we going to do if we start losing income. He said we are assuming that we are going to make the money that is being quoted on the budget. He asked if there would be a review or check of some sort to check that out. He said it is important.
