

**BALLOT DRAWING ORDER FOR CANDIDATES FOR
MAY 4, 2024 GENERAL CITY OF ALPINE ELECTION**

The Drawing for Place on Ballot took place in Alpine City Council Chambers located at 803 West Holland Avenue on February 23, 2024, at 2:00 P.M. All candidates for May 4, 2024, General City Election were invited to participate in the drawing. For the Ward 4 race, two pieces of orange paper were folded in the same fashion and individually marked as "1st Place on the Ballot" and as "2nd Place on the Ballot." The papers for the race were placed in a clear bowl and shuffled by the officiator.

The candidate, or candidate designee, who filed the Application for Place on the Ballot first had the opportunity to draw a folded orange paper first. In the Ward 4 race, Lori A. Griffin filed for office on 2/2/24 and Lucy E. Escovedo filed on 2/12/24. In the case that the first candidate or designee was unavailable, the next candidate or designee had the opportunity to draw a folded orange paper first. If both candidates or their designee were unavailable, a witness would draw for the candidate who filed first. The results were random and two witnesses were present. The results may be found below:

- Lori A. Griffin or her designee drew the folded red paper first.
- Lucy E. Escovedo or her designee drew the folded red paper first.
- A witness present drew the folded red paper on behalf of the candidate who filed first.
